In accordance with New City Library Bylaws, Article IV, Section 3(a): “A Resident of the Service Area who wishes to become a Trustee must be eighteen (18) years of age at the time of the Annual Meeting, shall possess a Library card for at least one hundred eighty (180) days prior to the election, shall be in good standing, and may not be an employee of the Library or within the immediate family of an employee.”

In accordance with Article IV, Section 4(e): “Any Resident who wishes to be included on the Ballot as a candidate for Trustee, including those not selected as candidates by the Board, must submit to the Board a petition (the “Petition”) signed by not less than twenty (20) eligible voters on a form provided by the Board. The Petition must be submitted by the second (2<sup>nd</sup>) Wednesday in November and must include all the information requested therein.”

Eligible voters are defined in Article III: “Any Resident of the Service Area who is a duly registered voter as determined by the Board of Elections of Rockland County is eligible to vote in elections for Trustees and for the proposed Budget.”

Please submit this valid Petition for Trustee of the Board in order to be automatically included on the Ballot along with the following four (4) required items to the New City Library Administration Office either in person, mail, email, or fax by **4:45 p.m.** on, or before, **November 11, 2020:**

1. This completed “Petition for Trustee of the Board”
2. A one-page personal “Statement of Interest” informing the Board why you want to be a New City Library Trustee and provide some information about yourself
3. Your “Photo Identification” (for example, a Driver’s License, Identity Card, or Passport)
4. Your “Proof of Residency” (for example, a utility bill—cable, water, or telephone)
